

## 2024 GoWest Solutions Advanced Leadership Program Scholarship Contest

## **OFFICIAL RULES**

- 1. By participating in the 2024 GoWest Solutions Advanced Leadership Program Scholarship Contest, all contestant-nominees agree to be bound by the contest rules and the decisions of the contest judges, which will be final.
- 2. The 2024 Advanced Leadership Scholarship Contest is sponsored by GoWest Solutions, headquartered at 18000 International Blvd, Suite 1102 SeaTac, WA 98188.
- 3. No purchase is necessary to enter the contest.
- 4. Participants in the contest may enter by completing a nomination form. All nominations must be received by the GoWest Credit Union Association by midnight of:
  - February 16, 2024, for the Advanced Leadership Program
- 5. The winner of the 2024 Advanced Leadership Scholarship Contest must be eligible to participate. Eligibility includes the following criteria:
  - a) Nominee-contestants must work for a credit union affiliated with the GoWest Credit Union Association.
  - b) Nominee-contestants must be available and have permission from their CEO to attend each of the in-person and virtual sessions scheduled for the 2024 Advanced Leadership Training Program and are responsible for travel costs associated attending the in-person sessions.
  - c) The contest winner agrees to work with the GoWest Credit Union Association Communications team towards our Newsletter about the program to be used at the GoWest Credit Union Association's discretion.
  - d) Follow-up within one month of the program end date with GoWest's Layna Officer to share how their experience with the Advanced Leadership Program has affected their career and their credit union.
- 6. Nominee-contestants must be willing to share insights derived from the program with their peers.
- 7. Videos submitted as part of the Leadership Scholarship Contest:
  - a) Must not contain any content that violates any third party's intellectual property or other rights; and
  - b) Must not contain offensive language, as determined solely by the GoWest Credit Union Association.
- 8. The winner of the 2024 GoWest Solutions Advanced Leadership Program Scholarship Contest will receive a complimentary registration to the GoWest Credit Union Association's 2024 Advanced Leadership Program that they have registered for, valued at \$3,600. Cash will not be awarded instead of enrollment, and the award is non-transferrable.

- 9. Odds of winning the contest depend upon the number of entries.
- 10. Winners will be contacted via email. If the winner fails to respond within seven days, the winner will be disqualified, and a new winner will be chosen from the candidates with the next highest number of votes in the contest. The winner need not be present to win.
- 11. All persons nominating themselves or accepting a nomination for the contest agree to allow the GoWest Credit Union Association to use their name to publicize the outcome of the 2024 Advanced Leadership Program Scholarship Contest and the program.
- 12. The award winner may be responsible for applicable state or federal taxes on the value of the contest prize.
- 13. The award winner is not eligible for additional GoWest Credit Union Foundation professional development scholarship funding for the Advanced Leadership Program.
- 14. Participants in the 2024 Advanced Leadership Scholarship Contest agree to hold the GoWest Credit Union Association, GoWest Solutions, and their affiliates and subsidiaries harmless from and against any claims and liability arising out of the 2024 Advanced Leadership Program Scholarship Contest.
