## 2024 Q1 State Advocacy Update

February 6, 2024

### Legislative Session 2024

The budget will be the focus of the 20-day 2024 session however property tax legislation is taking center stage with several pre-filed property tax related bills already filed and more anticipated. Several social issues-related bills are popping up as well. We anticipate ESG-related legislation will be filed as well. The conflict between the Freedom Caucus and Wyoming Caucus, the Republican factions of the legislature, is growing as the session and election filing periods draw near.

Credit Union legislation "[HB 86 - Vehicle lien-amendments](#)" will start in the House. Introduction will require a two-thirds majority of the House (41). If introduced the bill will likely be referred to the House Transportation Committee.

Working with the E-Titling Working Group members, a request for an Interim Study Topic will be submitted to the Joint Transportation Committee by the March 1 deadline.

## 2024 Interim

### Spring – Fall 2024

- Track and participate in Jt. Transportation Committee meetings on Electronic Titling and other topics affecting credit unions.
- Continue work with Financial Literacy Workgroup and determine path forward for Wyoming's 48 school districts adopting financial literacy education and/or graduation requirements.
- Track and participate in Interim Committee meetings on relevant topics.

### April – July 2024

- Track legislative campaigns and engage and support where appropriate. Mid-May is the candidate filing deadline.

### March – December 2024

- Continue implementation of [Advancing Public Funds Legislative strategy](#)

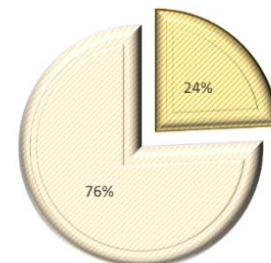
