Grassroots Engagement Update

There are many grassroots successes to celebrate for your work in 2024. These include over 3,500 unique points of engagement with elected officials and regulators throughout the year. This includes engagement during legislative sessions, campaign events, and official meetings. These touchpoints are essential to effective advocacy, and we are looking forward to even more engagement in 2025.

We are also proud of the continued emphasis on advocacy training and preparation. More than 300 credit union advocates received training across several programs to prepare them

as advocates, advocacy coordinators, and key contacts including Advocacy 101 & 201, MAXX Training, and Key Contact Training and Advocacy Coordinator calls.

This emphasis on training carries through to the development of tools and resources for credit unions to enhance their internal advocacy efforts. This bolstered resource library includes updated expectations for Advocacy Coordinators and Key Contacts.

The Grassroots and Political Committee was essential in helping guide the work of our team this year and helped us to develop advocacy training videos and topical resources to enhance educational materials for member credit unions to use in training advocates internally.

Finally, there were over 2,500 responses to Calls to Action for both state and federal legislative priorities. These are essential opportunities to get our message out and clearly communicate credit union priorities to lawmakers.

As we prepare for 2025, we know that these successes are just the beginning of what we can accomplish, and we fully anticipate bringing even more vigor to the mobilization of GoWest region advocates.

Political Engagement Update

As We Kick Off the New Year, we are thrilled to share the strides we've made in advancing our PAC efforts over the past year. Finalized totals will be reported after January 21, but here's a snapshot of the remarkable progress we've achieved:

State Highlights (Advocacy Toolbox - Reports)

- Arizona: Achieved 40.1% of its fundraising goal, raising \$25,146.50 so far.
- Colorado: Reached 65.5% of its 2024 goal, raising \$48,644.60.
- Idaho: Exceeded its goal at 100.9%, raising \$41,267.00.
- Oregon: Surpassed its goal, raising \$115,944.30.
- Washington: Reached 65.7% of its 2024 goal, raising \$87,161.10.
- **Wyoming**: Exceeded its initial goal, set a stretch goal, and achieved **74.1%** of that goal by raising **\$18,517.80**.

Regional and Historical Milestones

- Total Raised in 2024: \$336,681.20, surpassing last year's total of \$310,986.
- Total Raised Since 2022: \$904,900.17—a clear testament to our long-term growth.
- Contributor Growth: 2,574 contributors in 2024, exceeding our previous best of 2,238 contributors in 2020.
- **Credit Union Participation**: **131 credit unions** participated in PAC fundraising in 2024, setting a new record over the previous high of **120** in 2020.

• **Affiliated Participation**: Over **55% of affiliated credit unions** across the GoWest region contributed in 2024—a record-breaking level of engagement.

With new tools on the horizon and a renewed passion for investing in our political engagement, we are energized and excited to set bold new milestones in 2025. These achievements highlight the unwavering commitment and collaboration of our credit union advocates and members. The momentum we built together in the past year sets the stage for even greater successes in the year ahead.
